

# Harrison Bay Future Ready Center eSports Club

## By-Laws

### Article 1. Club Name

The name of this club is Harrison Bay Future Ready Center eSports Club, hereafter referred to as the club.

### Article 2. Purpose of the club

1. We will develop an environment to support competitive gamers. This will include but not be limited to; game strategy, game techniques, college recruiting, and other game related material.
2. We will develop a support system to help students maintain a good discipline record and good grades so they can continue to compete.
3. We will raise funds to help cover the cost of competitions, club gear, and other club related costs.

### Article 3. Membership

1. Membership is open to any currently enrolled Harrison Bay Future Ready Center student.
2. Only currently enrolled students are allowed to run for club offices.
3. Current members may bring up new business during the open floor session of regularly scheduled meetings.

### Article 4. Officer Positions

1. The officers of this club shall be President, Treasurer, and a Team Captain for each team in the league. Officer positions may be deleted or established by a majority vote of the club.
2. President and Treasurer will be elected for one year by a vote of the club at the beginning of the school year. Both president and Treasurer may also serve as a Team Captain.
3. Team Captains will be chosen based on skill or on team vote for each season. The Team Captain will serve for the length of the season.
4. Officers must be currently enrolled Harrison Bay Future Ready Center students and current on HSEL game fees.
5. Officers cannot miss more than two meetings in a gaming season.

### Article 5. Officer Duties

1. President – principal officer and is responsible for leading full club meetings and activities in accordance with guidance established by Harrison Bay Future Ready Center administrators and these bylaws.
2. Treasurer – shall maintain all of the financial holdings of the club on a season basis of whenever the faculty sponsor or president deems necessary. The treasurer shall make a report to the club before election of a new treasurer or in the event, the treasurer leaves office before regular elections.
3. Team Captain – shall coordinate game schedules, player participation, strategy sessions, practice sessions, and complete all competition planning and reporting.

## **Article 6. Faculty Sponsors**

1. There must be a faculty sponsor(s).
2. Sponsor(s) may vote in meetings and participate in club activities.
3. Sponsor(s) must be present at all club meetings.
4. A sponsor will be responsible for supervising elections and maintaining order within the club.
5. A sponsor will work closely with the club officers in business matters of the club, including publicity in the school like the school website.

## **Article 7. Voting**

1. Each member may vote.
2. A majority of the club must approve all proposed changes to these bylaws.

## **Article 8. Dues**

1. There are no club dues.
2. The students are required to cover the HSEL game fees for the seasons in which they participate.

## **Article 9. Meetings**

1. General meetings will be held at the beginning of each new season. Meeting locations and times are subject to change by a consensus of the club's officers.
2. At least one sponsor is required to attend each meeting.
3. Team strategy meetings may be held as frequently as once a week. Each team is responsible for running the strategy session for their game and platform.

## **Article 10. Activities**

1. Competitions run by HSEL
2. Fundraisers – proceeds from fundraisers will be deposited into the school's account via the school's business office. Fundraisers may be Lan parties, school branded merchandise, or other opportunities that may come to the clubs attention.

## **Article 11. Code of Ethics**

1. All members will be responsible for their actions and respect the genius of others' work and property.
2. All members will sign and will be held accountable for the Student Player Contract.
3. Software piracy in not allowed.
4. All HSEL rules and regulations must be abided during competitions.
5. The club will operate under school policy.
